



# **BNCC ACCREDITATION PROCESS AND PROCEDURES**

The Britain Nepal Chamber of Commerce (BNCC) is a non-profit membership organisation dedicated to fostering and enhancing bilateral trade and business relations between the United Kingdom and Nepal. To become an accredited member of BNCC, interested businesses must follow the process outlined below.

## Accreditation Process

### 1. Complete the Application Form

Prospective members must complete the official BNCC accreditation application form, providing accurate details about their business profile, including the nature of their work, objectives, and connections with the UK-Nepal business ecosystem.

### 2. Application Submission

Submit the completed application form and required documents via the BNCC website or email to the designated contact provided on the application form.

### 3. Review and Assessment

The BNCC Accreditation Committee will review the application based on predefined criteria to ensure the applicant aligns with the organisation's mission and values.

### 4. Membership Approval

If the application meets all necessary requirements, the applicant will receive an approval notification. In the case of incomplete or unclear submissions, BNCC may request additional information.

### 5. Membership Fee Payment

Approved applicants are required to pay an accreditation membership fee of £500. The membership is valid for a period of three years.

### 6. Welcome and Orientation

New members will be formally welcomed to BNCC and provided with an orientation package detailing member benefits, events, and resources.

## Accreditation Criteria

To qualify for BNCC accreditation, applicants must demonstrate the following:

- **Connection to UK-Nepal Relations:**

Active or prospective involvement in trade, investment, or business activities that promote bilateral relations between the United Kingdom and Nepal.

- **Business Integrity and Ethics:**

Adherence to ethical business practices and compliance with local and international laws.

- **Alignment with BNCC Goals:**

A clear understanding and support for BNCC's mission to enhance economic collaboration and community building between the two nations.

- Networking opportunities at high-profile events, business forums, and training programs.
- Market insights, including updates on trade regulations, trends, and opportunities in UK and Nepal.
- Advocacy for policies that promote UK-Nepal trade and commerce.
